To receive a TN visa, you must submit the following forms and documentation: Form DS-156, Nonimmigrant Visa Application completed and signed. Form DS-157, Supplemental Nonimmigrant Visa Application by male applicants between 16-45 years of age.

TN Visa Application Process And Documents Checklist

The employee's unexpired Form I-94 together with their unexpired foreign passport is acceptable as a List A document for Form I-9. In the alternative, employees in TN status may present a List B document with a List C document. In this case, a Form I-94/I-94A indicating admission in TN status would be acceptable as a List C#8 document.

NAFTA (TN) Visas | USCIS

Proof the TN nonimmigrant is maintaining his or her TN nonimmigrant status. At a CBP- designated U.S. port of entry or at a designated pre-clearance/pre-flight inspection station. Canadian citizens. No visa required. Proof of Canadian citizenship; Proof of relationship to the TN nonimmigrant, such as a marriage certificate or birth certificate;

TN NAFTA Professionals | USCIS

The following documents must be provided to USCIS and/or border officials in order to be issued a TN visa: Proof of citizenship. Form DS-160, Nonimmigrant Visa Electronic Application. Documentation of diplomas, degrees (and evaluations of foreign degrees if necessary), certificates, and professional memberships.

TN Visa - Requirements of the NAFTA TN Visa For Canadian ...

If a Canadian citizen is applying for the TN visa status at a land border, preflight clearance in Canada or airport in the US (see Find Out Where a Canadian Citizen Can Apply for a TN Visa for more info on this), no government forms are required for the application, unless the application was prepared by an attorney, in which case the application package will contain the Form G-28, Notice of Entry of Appearance as Attorney or Accredited Representative.

The maximum period a TN visa can be granted for is 3 years. On paper, TN visas can be extended in three-year increments indefinitely as long as the holder satisfies all the requirements. The reality of extending the TN visa is unfortunately not that simple. There are many factors that can influence the time you can stay in the U.S. on a TN visa.

Have US dollars available to pay for your TN visa which is US\$50 for the application and US\$6 for the I-94 issued (beginning in 2014, your TN visa is approved and recorded online by the US Customs officer you will be dealing with. The TN visa was created by the North American Free Trade Agreement (NAFTA), to ease the path toward a visa for professional-level workers from Canada as well as Mexico. As of July 1, 2020, the United States-Mexico-Canada Agreement (USMCA) replaced NAFTA including the provisions that govern the TN visa.
